

# CITY BUILDING PERMITS



Building or zoning permits are required for ALL projects including sheds, decks, signs, cement work, etc. Please make sure that you submit your building permit/zoning application in enough time for it to be processed by Avon City Hall. The

Zoning Administrator and the Building Inspector both need to review the application and sign off on all projects.

**There will no longer be any over the counter (same day) permits.**

Please plan accordingly as to when you will be starting your project. Thank you.
